

FERTASA SERVICES AND ACTIVITIES

In 2012 committee members of the Fertilizer Society of South Africa (FSSA) identified 15 services and activities that were considered essential to the future and existence of the society.

In 2016 the importance of each of these 15 activities and Fertasa's overall performance was rated. The result of this survey is on the Fertasa website.

Almost 4 years have elapsed since the 2016 survey and the membership of Fertasa has since then doubled. It was therefore decided that a further survey should be done.

Four tables have been compiled and committee members were requested to complete them. The survey was made available online to all 78 member companies. The response reflected the opinions of 48 member companies.

Fertasa's first priority is liaising with the Registrar and his people (DALRRD) regarding the new Fertilizer Bill and Fertilizer Regulations (Table 1).

The value of the Basos-Facts course, the *Fertilizer Handbook and* Fertasa events as well as the importance of the Fertasa Code of Compliance System, was seen as very important.

It is also important to note that all 23 services on the list were regarded as important, with the lowest ranking being 62.5%.

The results of the survey are shown in Tables 1 to 4.

The importance of Fertasa's committees to members is shown in Table 2. The majority prefer to be represented on the Regulatory and Technical Committees and least of all the Educational Committee.

The benefits of Fertasa membership are shown in Table 3. Free publishing of company names in the *Fertilizer Handbook / Bemestingshandleiding* was rated as the main benefit.

Fertasa's overall performance is shown in Table 4. The majority of members rated the service as good (58.33%) and very good (18.75%), giving a total of 77.08% of members reporting a positive experience with Fertasa's performance. The challenge is to reduce the number of members rating Fertasa's performance as neutral or poor (22.91%).

Comments or suggestions

Table 1: Important Services

- 1 Get more involved with maintaining ethics and quality assurance of fertilizer industry
- 2 Database of product registration information which can be accessed by members to upload / edit / download information = 5
- 3 Harmonization and simplification of quality testing procedures for various types of fertilizer ingredients = 4

Table 2: Importance for members to be represented on Fertasa's committees

- 1 Members should be active in matter of the related committee (e.g. members should not have a marketing representative in a Regulatory Committee) = 100
- 2 5 = Members should be urged to act responsible through participation, replace 'like minded' with 'different minded' approach
- 3 Harmonization to improved security procedures/communications regarding the theft of fertilizer/bags/etc. as well as its disposal/dumping of these products, including the importation of illegal/banned/out of spec fertilizer products = 4
- 4 People serving as committee chairs must be professionally active in that type of discipline (e.g. the chair of the Regulatory committee must work in a regulatory field).
- Current to manage the relationship with DALRRD. It is up to FERTASA to ensure that DALRRD functions more efficiiently, and if DALRRD do not respond appropriately then it must be taken to another level that will result in positive change

Table 3: Benefits of Fertasa membership

- Benefits for customers doing business with Fertasa member organisations as appose to doing business with non-member organisations should be promoted more (ie. peace of mind, assurance, Fertasa back-up for the customer etc.) = 4
- 2 5 = ALL members of Fertasa should have voting rights, proportionate of course

- Need to take more action and less discussion. Board members should be more representative regarding the industry
- 2 Fertasa could be more involved with addressing "hoax operators" in the industry, ie. Box fertilisers, "magic" fertilizers etc.
- 3 Fertasa would manifest the difference for new fertilizer submitted through fertasa. I mean there is not difference in terms of approval time with those who submitted their dossier directly to DALRRD. There should be a differences.
- 4 Fertasa should / must 'claim' its place of importance and responsibility to act as voice of Plant Nutrition industry both towards Government and other industries. Fertasa, responsible for its industry - It should be allowed to act as Representative and Regulatory body
- 5 The management of the relationship with DALRRD has been very poor and can be improved.
- The Fertilizer Industry doesn't speak with one voice. Everybody has their own opinions. We don't work together as a team for the common good of the Industry. Take for instance the Gr 3 Guidelines it was supposed to help with the registration process, but instead has complicated it and led to more expensive applications.
